- 1.The routine monthly check has been carried out. The equipment is all safe. Grass near the stream to be strimmed. Signs now in place. The electricity wires near the trees are now touching the trees. HiLine are the responsible contractors. They have been out on site. LJG to enquire who is responsible for the trees.
- 2.ROSPA have inspected and following their report PC made aware that the gate is dangerous and has a crush point which could cause injury. GC has made enquiries with Somerlap about a replacement gate and will report back when quotes received.
- 3.Play area wall-the works should start on the 11 August. WA said PC will probably need a no climbing sign when the HERAS fencing is removed.
