

#### **Shepton Priorities**



 Whilst there have been no reported incidents of Anti Social Behaviour within the West Pennard/West Bradley area for the last 3 months. It is being brought to our attention that there is increasing incidents of anti social behaviour around Shepton Mallet, this is in the form of teenagers banging very loudly on front doors and running away. We are working with schools and have identified some of the youths responsible and they have been dealt with via education and out of court disposals.





 The wider Shepton area has experienced a small number of thefts of small plant machinery & tools from outbuildings/sheds. Please secure vehicles and buildings and give consideration for CCTV and lighting to deter offenders.

#### **Rural Crime Update**



• We are continuing to see the theft of trailers and quad bikes force-wide with Ifor Williams trailers being the trailers of choice. Offences are sporadic and not specific to any area, thus currently we have not identified any trends or series.



• We are continuing to push crime prevention and target hardening by utilising security marking including Selecta DNA and Datatag trailer marking kits.



• We are purchasing 10 poacher blocks which will be utilised in areas that have been persistently targeted with deer poaching and hare coursing, this is a new initiative and will initially be a trial, if successful more will be purchased.







# **Avalon Marshes Partnership**

















1,500 hectares of nationally important nature reserves and habitats managed by the members of the Avalon Marshes Partnership.

- Catcott Nature Reserve
- Ham Wall National Nature Reserve
- Honeygar Nature Reserve
- Huntspill River
- Shapwick Heath National Nature Reserve
- Shapwick Moor Nature Reserve
- Westhay Moor National Nature Reserve



The varied landscape of the Avalon Marshes provides vital habitats for a wide range of plant, animal and insect species.

There are many habitat types to discover including open water, reed-bed, mire, fen, meadow and wet woodland.

Visitors can access the marshes at the reserves which have numerous **trails** and **hides** and host **events** and **activities** for all ages.

None of the reserves are currently served by public transport. They all have car parks, but only Shapwick Heath and Ham Wall have visitor facilities.



#### **Birds**

Owls, birds of prey, ducks, herons, swans, waders and warblers. 'The Big Three' -Marsh harrier, bittern and the great white egret. Starling Murmurations from November to February.




























#### **Mammals**

Newts, toads, frogs, slow worms, snakes, lizards, snails, beetles, grasshoppers, butterflies, dragonflies, moths and mussels.


























## Flora & Fungi

# Who Currently Visits the Avalon Marshes?

- The Avalon Marshes receives around 220,000 visitors per year.
- The majority of visitors are fairly local Over half are **travelling less than 20 miles** (55%), in some reserves this rises to 75%.
- The Avalon Marshes is a destination Most of our visitors come on a day out from home (63%), with fewer on a short trip or passing through (29%).
- We have an engaged and local audience **Over half visit at least once a month** (52%) and a further third are visiting 2-4 times a year (32%).
- It's also an **older audience, with 70% being over 55** They mostly visit alone or with one other adult (82%). Around 12% of our visitors identify as having a physical or mental impairment.
- **Birdwatching and wildlife** is by far the top main reason for visiting (53%). A further 22% are visiting the café and 14% are coming for a wildlife spectacle.

# **Avalon Marshes Centre**

Located between Westhay and Shapwick, this is the gateway to the Avalon Marshes and a visitor hub with a varied programme of events.

Owned and operated by Natural England, it offers visitors a wide range of facilities for visitors exploring the area:

- Accessible toilets
- Free car park
- EV charging points
- Visitor information point
- Outdoor seating and picnic areas
- Wildlife pond
- Bicycle racks



# **Avalon Marshes Centre**













### **Events and Activities**

- Our grounds and meeting rooms play host to a range of community events throughout the year.
- Some are organised by the members of the Avalon Marshes Partnership, but most are members of the local community who need cheap and a flexible space.
- In the past year we've had exercise classes, craft workshops, talks, film screenings, citizen science days, mindfulness sessions, wildlife study days, forest schools, photography workshops, Nordic walking... the list goes on!




# Connecting People with Nature

- People with a greater connection to nature are more likely to behave positively towards the environment, wildlife and habitats.
- Our partnership aims to ensure more people can access nature-rich places and spend time benefitting from the natural environment.
- We run workshops, walks, talks and activities for children and adults and provide resources to help groups access and use nature rich spaces.
- In 2025 we begin an exciting partnership with Somerset NHS to offer green social prescribing opportunities.








# "Step, Ride, Thrive" Project Overview

- Goal: Promote active travel and community health through an integrated community transport project
- **Key Initiative**: Extend #668 Libra bus service to stop at the Avalon Marshes Centre.
- **Broader Scope**: Walking, cycling, and wellbeing initiatives, with free events and activities offered throughout project.
- 2025 Funding Plan: Apply for up to £35,000 from the SALC Community Health & Wellbeing Large Grant via the LCN partnership for pilot scheme.
- 2026+ Funding Plan: 20-year funding through Defra's 'Adapting the Levels' project

- **Bus**: Pilot project for 6-month operation (April–September 2025), weekday service with four daily stops.
- Walking: Promote connections to walking trails and cycle paths, provide free guided tours and wellbeing events.
- Cycling: Partnering with On Your Bike to offer events at parishes in LCN. Add racks on buses. At AMC, install secure cycle parking, e-bike charging points and a bike tool station.
- Resources: Develop maps, trail guides and active travel challenges.
- Promotion: Ensure the new bus route and active travel activities are well publicised and used.



#### **Health & Wellbeing**

 Foster physical activity (walking, cycling), green social prescribing and tackling isolation through social connections

#### **Accessibility**

 Enable equitable access for low-income families, elderly residents, people with health issues, and those without access to a car

#### **Sustainability**

 Reduce car dependency and environmental impact

#### **Economic Benefits**

 Boost visitor numbers to support local businesses and promote conservation



# Who will benefit?

- All residents of the Avalon & Poldens LCN through the bike scheme, and particularly those in parishes with pre-existing #668 bus connection.
- Visitors to the Avalon Marshes: local walkers, wildlife enthusiasts, dog walkers, families, cyclists, runners, tourists, social and health care providers.
- Hard-to-reach groups: older people, people living in low-income households, people with long-term health concerns/ disabilities.

# Partnering with On Your Bike

- A registered charity dedicated to empowering individuals through hands-on training to refurbish and recycle unwanted bicycles.
- They offer a range of workshops and support to organisation sand schools promoting cycling.
- Dr Bike Session offers free safety checks and adjustments on bikes for the public. Cost £250 for 4 hours.
- School Maintenance Course for year 5+ that includes an M-Check, puncture race and a quiz for 1 hour per group. Cost £400 for 4 hours.



# Pilot Metrics & Future

- **Data Collection:** Gather user metrics and community feedback during the pilot to make the case for future investment.
- Impact Assessment: Evaluate health, transport use, and environmental outcomes of the pilot.
- Long-Term Goals: Explore sustainable expansion to evenings and weekends and further connections from the LCN to existing bus routes.
- **Funding Plan**: We are applying for 20-year funding through Defra's 'Adapting the Levels' project to make the pilot permanent. To be confirmed by Jun 25.

# **Next Steps**

- The LCN needs a council to be the lead applicant for the SALC funds. They must have General Powers of Competency and sufficient S137A capacity to receive a grant.
- Indication whether financial support would be available from your parish to support the project. If each council in the LCN could allocate £565, the full cost of the new bus route could be covered.
- **Ideas** for how we can provide more active and sustainable travel options in the area
- Letters of support showing that the project is of value to the parishes in the LCN, submitted by 21 Feb.
